5) PLAY AREA - PLAY EQUIPMENT

a) Funding

The **PC** informed the meeting, that although funds have been set aside for this project by the Parish Council, there will still be a need to look for additional funds

b) Quotes

The PC has obtained several quotes and has received several brochures from companies. No decision can be made at this present time until the issues of the damaged wall on the boundary of the Play Area is rectified.

c) Maintenance Issues

The JB has spent some time in consultation with a local solicitor to ascertain the ownership of the damaged wall at the Play Area. It would appear that, by default, the Parish Council are responsible for the wall. JB and the PC have also been in consultation with Stuart Hibbert (SH) from SBC re the vegetation and trees next to the wall. SH has advised the Parish Council that the vegetation and overhaning branches need to be removed from the Play Area side of the boundary. SH has now submitted a quote for this work which will be carred out by SBC at a cost of £450.00 ex vat. This was approved by the Parish Councillors present at the meeting SH also suggested that the Parish Council obtain the services of a Structual Engineer to look at the wall and give a professional assessment of the damage and what action needs to be taken. AS to investigate and contact with the name of a suitable Structual Engineer. JB and and PC are to meet with the owner of Orchard House to convey the advice given by SH re their side of the boundary and a meeting is to be arranged.

d) Risk Assessment

The PC had both forwarded the Risk Assessment for 2019-20 to Parish Councillors but also circulated paper copies for them to view. After discussion the Risk Assessment for 2019-20 was approved. JS & GT

10) VILLAGE ISSUES

a) Green Lane Housing Developments

AS informed the Parish Council that he had arranged for a dog/waste bin to be placed at the enterance to Saltergill Lane and this would be emptied by SBC. **AS** also informed the meeting that, once the roads and footpaths at all the housing developments on Green Lane have been adopted by SBC, the introduction of further bins will be sited at the developments. The cutting of grass/ heldges and general management of the sites would still be the responsibility of the management companies.

b) Rural Crime

JS reported that she had placed notices re Rural Crime around the Parish. This is an issues that we all need to remain vigilant about. Residents to be encouraged to report anything suspicious to The Police on 101 and use what3words app. to identify the position of any incidence.

c) Forest Lane SID

The **PC** reported that the SID which is positioned to the west along Forest Lane has been damaged. It is thought that it this has been caused by a large vehicle passing. It has now gone away to see if it can be repaired and will be returned to the site if repairable.

d) Village Field Maps

The **PC** reported that Dr. Alistair McClee has contacted the Parish Council re some village field maps that he has found. **JB** to speak to him and advise that they should either be put into the history archives or be framed and placed in the village hall is possible.

12) ROAD SAFETY

a) Crossing Green Lane

It had been hoped that the Parish Council would have been given an update re the installation of safe crossings along Green Lane.

b) Christmas Tree, Play Area

The **PC** informed the Parish Council that she had been contacted by SBC re providing, installation, lighting and barrocades together with the removal in January of a Christmas tree. The Parish Council **unanimously all agreed and approved** the installation of a tree in the Play Area.

c) Rural Crime

JS brought to the attention of the Parish Council the problems of rural crime.

d) Christmas Event

JB spoke to the Parish Council re the now annual Christmas Event which is funded by the Parish Council. The event is to take place on Sunday, 15th December from 5.30p.m. The format is hoped to remain the same as in previous years. More details will be provided at the October Parish Council meeting and costing.

e) Newsletter

JB informed the Parish Council that a newsletter will be going out to residents later in the year and, as previously, all community groups will be encouraged to advertise their festive events on the back of the newsletter.

f) A67 Drains

AS reported that the drains on the A67 are blocked and urgently need attention.

11) ROAD SAFETY

a) Crossing Green Lane

It had been hoped that the Parish Council would have been given an update at the meeting re the installation of safe crossings along Green Lane.

b) Parking Issues - Knowles Close/Forest Lane

Several residents have expressed their concern re the parking of vehicles close to the junction of Knowles Close and Forest Lane which causes a problem to drivers seeing both oncoming but also exiting vehicles from both Knowles Close but also Ash Grove. It was pointed out that there is a lay-by on Knowles Close that can be used for parking which would alleviate this problem.

c) Parking Issues

Whilst there have been difficulties at the local Primary School during the construction work being carried out on the roof of the school and the school car park not being in use and staff needing to park outside of the premises, other residents has been less that considerate when choosing where to park. Strathmore Drive, Pump Lane and The Green have seen some irresponsible parking.
